DESCRIPTION OF RISK, RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNIFICATION

I, the undersigned Attendee (the “Attendee”) and/or the Attendee’s legal guardian if the Attendee is a minor, understand that this Agreement is a binding legal agreement. I understand that this Agreement is made for the benefit of Parkbridge Management Limited Partnership or any of its affiliated entities (collectively, “Parkbridge”), Parkbridge Lifestyle Communities Inc., and their respective partners, directors, officers, agents, representatives, employees, independent contractors, sponsors, subcontractors, successors and assigns (collectively, the “Releasees”).

I understand that Parkbridge will not permit me to attend at or participate in Kids’ Club (the “Activities”) unless and until this Agreement is signed by me. In consideration of permitting the Attendee to participate in the Activities, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Attendee and/or the Attendee’s legal guardian acknowledge and agree to the following terms:

I understand and acknowledge that there are many risks, dangers, and hazards which are inherent in attending at or participating in the Activities and using supplies provided by the Releasees for the purpose of carrying on the Activities (the “Supplies”), which could result in damage, loss, physical injury, illness or death, and which risks, dangers and hazards may include, but are not limited to: defective, dangerous or unsafe conditions during the Activities or in the use of the Supplies; mechanical failure or negligent design or manufacture of the Supplies; insufficient warnings, directions, instructions or guidance as to the Activities and the use of the Supplies; Attendee’s lack of experience, knowledge, and skill in the Activities and the use of the Supplies; the transmission of communicable diseases; the conduct and/or negligence of the



Attendee or other persons participating in the Activities; or negligence on the part of the Releasees, including the Releasees' failure to take reasonable steps to safeguard or protect the Attendee from the risks, dangers and hazards associated with participating in the Activities, including but not limited to those risks, dangers and hazards listed above (collectively, the "Risks"). I hereby further agree to:

(a) waive any and all claims or causes of action that I have or may in the future have against the Releasees, including without limitation the right to make a third-party claim or claim over against the Releasees, in connection with attendance at or participation in the Activities, including but not limited to claims arising due to negligence, breach of contract, breach of warranty, breach of statutory or other duty of care, including any duty of care owed under the Occupiers' Liability Act, or the failure on the part of the Releasees to take reasonable steps to safeguard or protect the Attendee from the risks, dangers and hazards associated with attendance at or participation in the Activities, including but not limited to the Risks listed above;

(b) release, discharge and forever hold harmless the Releasees from any and all liability for damages, loss or expenses arising as a result of the Attendee's attendance at or participation in the Activities; and

(c) indemnify and hold harmless the Releasees for any and all damages, loss or expenses (including legal costs) of any kind arising in connection with any claims, demands, or causes of action of any kind whatsoever including those involving negligence on the part of the Releasees resulting from the Attendee's attendance at and/or participation in activities of the Facility.

I am not relying on any oral, visual, or written representations or statements made by the Releasees with respect to the safety of the Activities other than what is set forth in this Agreement. Additionally, I further acknowledge and agree that where Supplies are provided by Parkbridge, Parkbridge makes no representation, warranty, or guarantee regarding the quality, suitability or availability of the Supplies.

I agree that this Agreement and all terms contained within are governed by the laws of the Province of Ontario. I hereby irrevocably submit to the exclusive jurisdiction of the courts of the Province of Ontario. Any litigation in any way relating to the Activities or to the matters addressed in this Agreement must be instituted in the Province of Ontario.

If any provision (or part of any provision) in this Agreement is unenforceable, such provision (or part of such provision) shall be severed and shall be inoperative, and the remainder of this Agreement shall remain in full force and effect.

I confirm I have read this agreement in its entirety, including all of its terms, that I fully understand its terms, understand that I have given up substantial legal rights by signing it and have agreed to the terms freely and voluntarily. I understand this agreement is binding on me, my executors, and administrators. I freely acknowledge that I am aware of the risks described above and I accept and fully assume responsibility for the risks.
